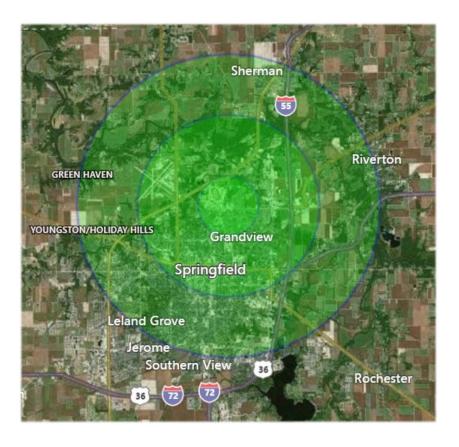

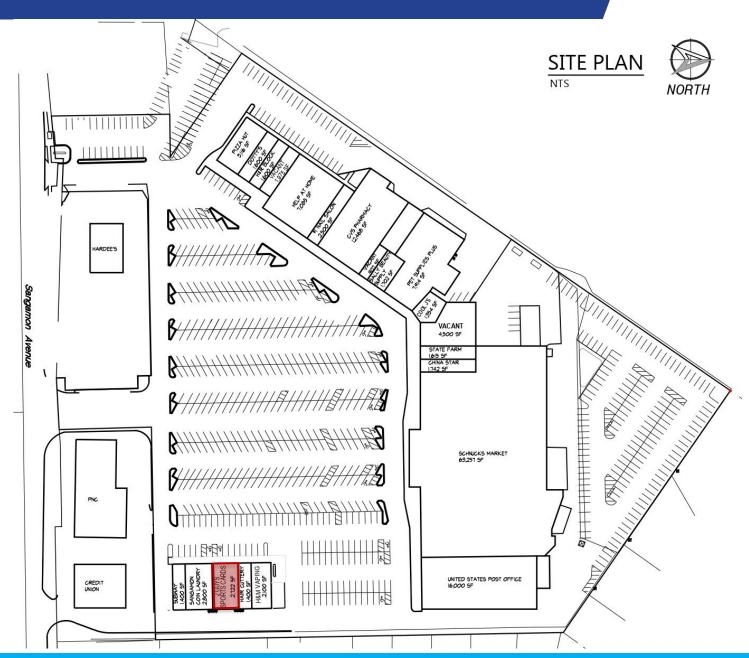

SITE PLAN

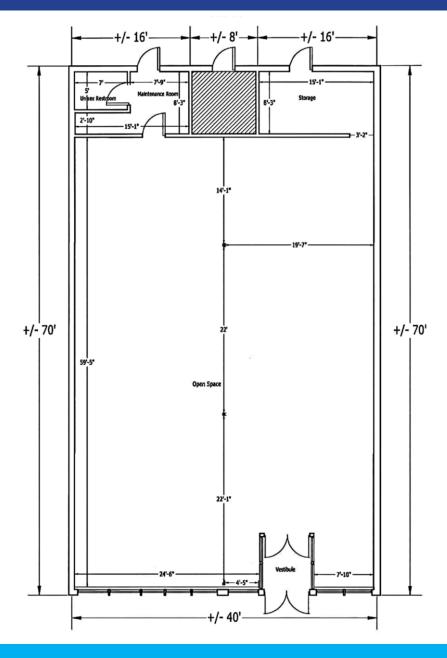
