Subject property is a 10,950 SF freestanding structure featuring roughly 6,000 SF of retail and +/-4,950 SF of warehouse space. The building was origionally constructed for Carpetland in 1974 and it has since been occupied by Flooring Depot and most recently converted into a liquor store. The open showroom layout offers prospective tenants significant flexibility to meet their space needs. The warehouse portion is fully heated and cooled, features suspended T-grid ceiling and a 900 SF mezzanine.
