Exterior walls are a combination of brick veneer and painted EIFS panels. The roofs are steel-joist supported metal decks covered with a low-slope TPO roofing systems and a pitched section finished with asphalt shingles covering the front elevation. The interior is finished with suspended ceiling tiles, painted drywall panels, and exposed structure in the stock room areas. Floors are covered with a combination of 12" x 12" floor tile and exposed concrete.

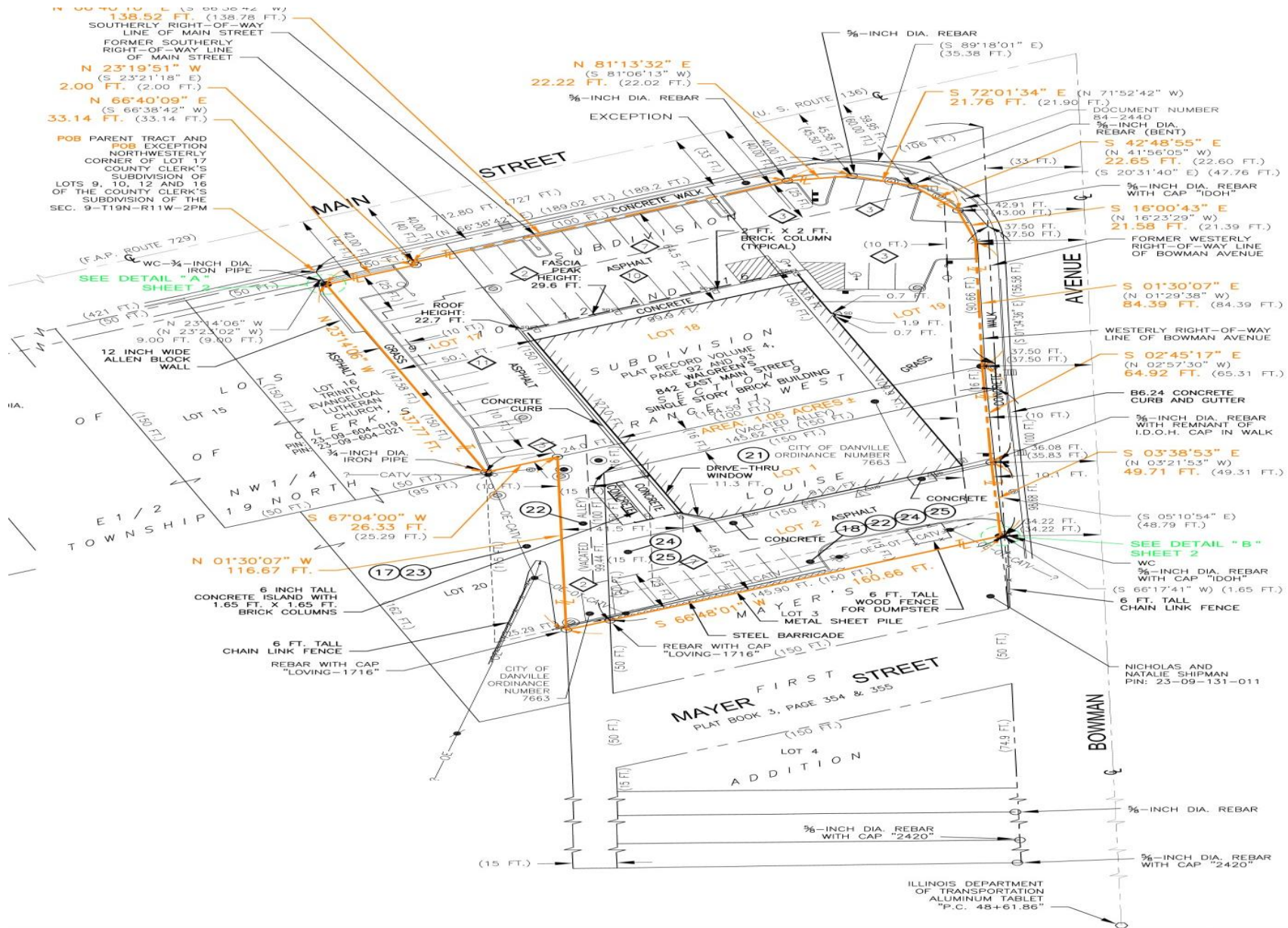

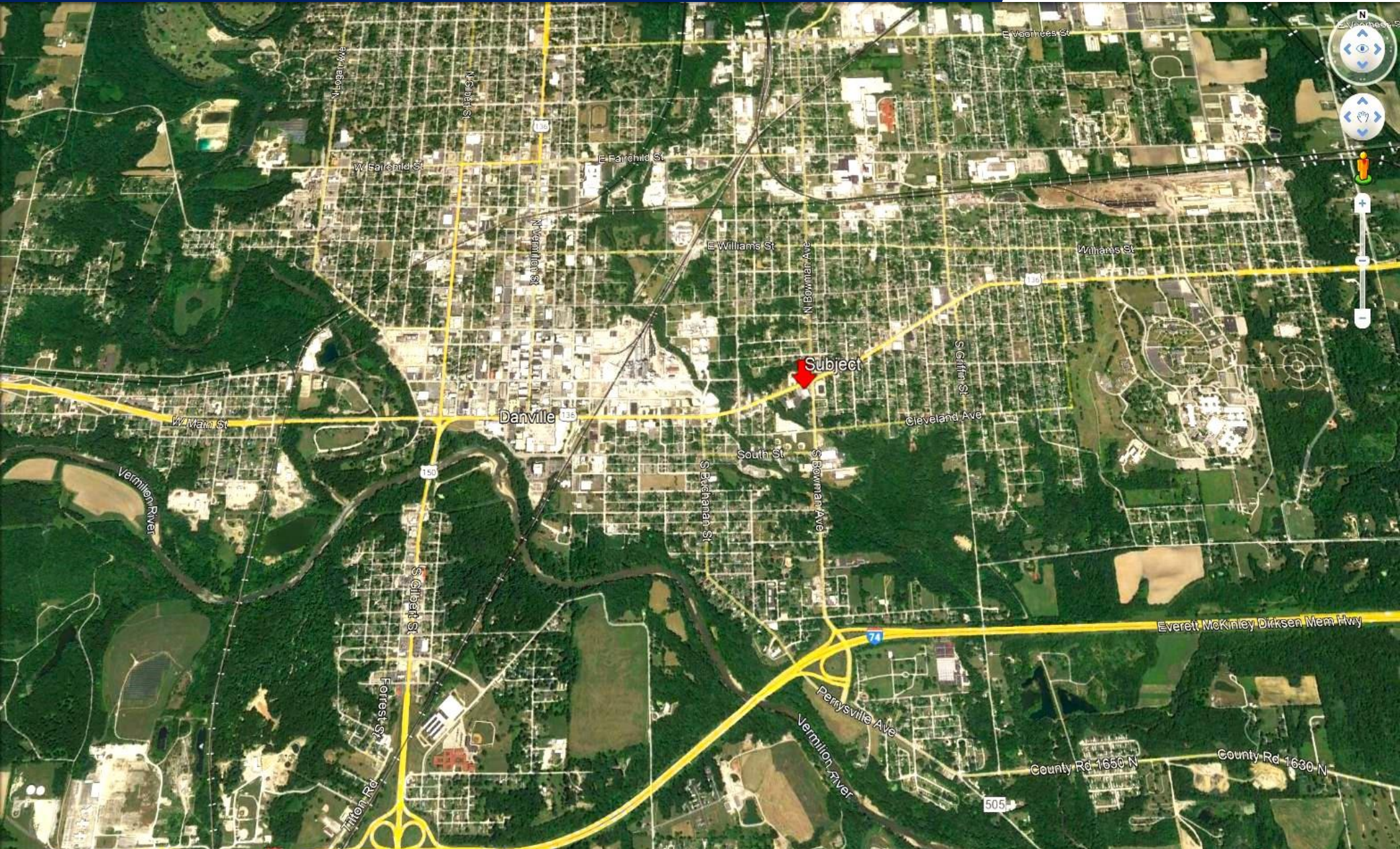

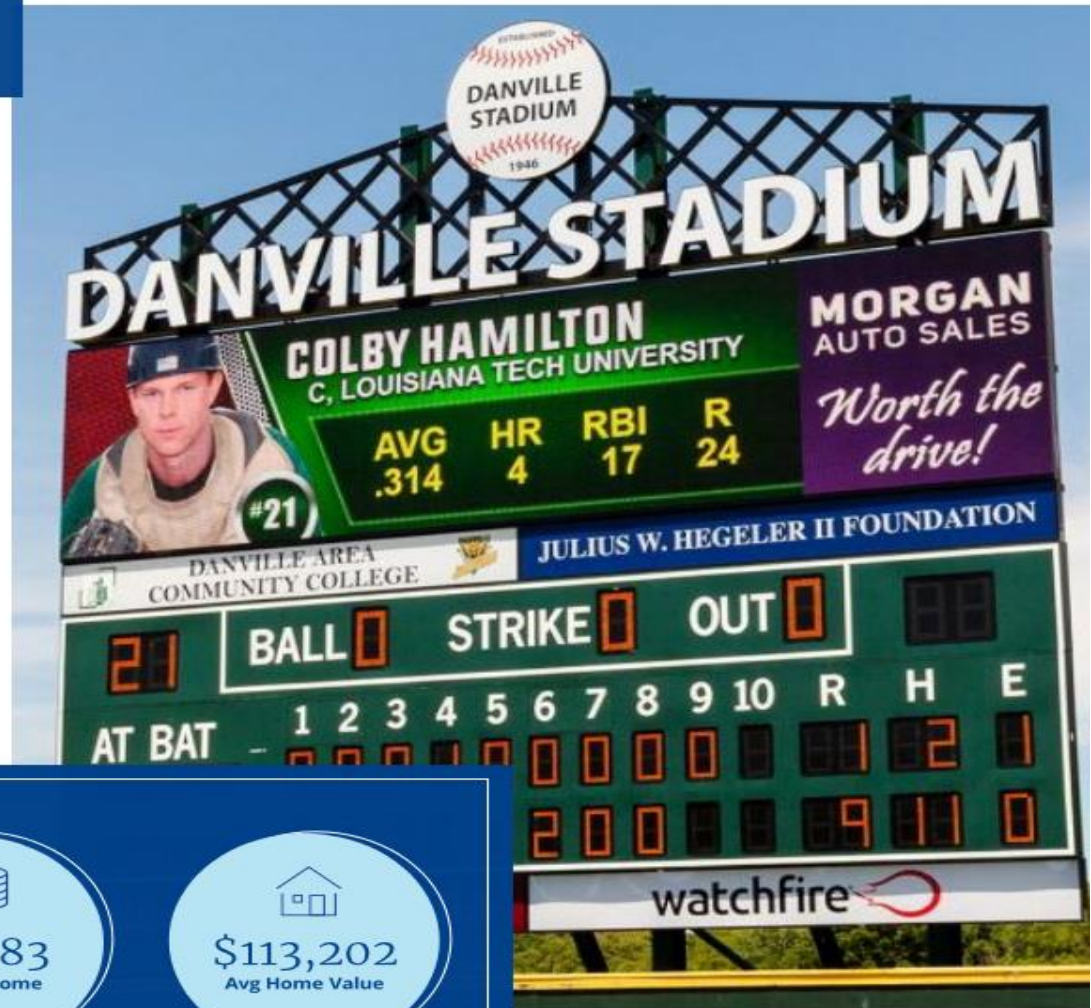
