Executive Summary

PROPERTY OVERVIEW

The subject property consists of approximately 6.22 acres located along Wildomar Trail less than 1 mile north of its intersection with Clinton Keith Road. The property sits in the middle of two of the most traveled I-15 off-ramps in Wildomar; Clinton Keith Road and Wildomar Trail, both having daily traffic counts of nearly 20,000 cars per day. Directly across from the property on Wildomar Trail is The Ridge Community which consists of over 300 single family homes, and to the south is a 200+ home community by Van Daele Builders. Additionally, the property sits just north of the large retail presence surrounding Clinton Keith Road and the I-15 freeway and is in close vicinity to schools that serve the local community.

ZONING


The subject property is zoned Rural Residential with a General Plan Land Use Designation of Very Low Density Residential. This allows for the development of detached single family residential units with a minimum lot size of 1 acre per dwelling unit. The VLDR designation is specific to the development of large lot homes of at least 1 acre each with limited agriculture and animal keeping permittance.




Wildomar, CA
